We lost Mozie on August 6, 2018. Mozie was owned by Lora Blair at Fox Run Farms and was evented by Mackie Blair. He was a huge (17.3 hand) Dark Bay Thoroughbred with a white star. He was one of the first Low Rent Ranchers. He lived with us for more than 10 years and touched almost all of the horses that have stayed with us. Mozie had a bad heart (which is why he retired), but it was made of gold. Many, many vet students got to hear his crazy heartbeat. And then they would get quizzed! So he taught them all. Mozie was one of the gentlest giants I have ever known. When he first arrived he was really not sure of the plan. He seemed like Oliver Twist. "This is not my beautiful house" he seemed to say. The first really cold night Lora had to run over in the dark and bring him his blanket. He loved his "binky" and would nicker at you and put his head down so you could put it on. That never ceased to crack me up. Once he figured out that he could pretty much go wherever he wanted any time he wanted, he embraced it wholeheartedly. He did this head bob thing and sang his "rap" song every time you came to feed. He would stick his head out of the window in his room and rap for his meals. It was hilarious. When he galloped in at feed time his hooves thundered louder than the others. Cash always won, but Mozie could shake the ground. Speaking of Cash, we lost him a few weeks before Mozie. They were the best of buddies. Cash and Mozie were the swim team. They would swim across the pond together like a synchronized dance. It was something to see. The both were dark bay with white stars. When I would go to the barn at night you could just see their stars peeking out of the barn. They became the Star Babies. Delilah has a star too so she joined the Star Baby Club. Mozie's big, broken, heart of gold watched over baby Fiona and her mom Splash when they were in the witness protection program at Low Rent Ranch (long story, bad divorce). He literally wrapped his body and that big old head around her and pulled her close. The light in her eyes came back and she was healed. It was beautiful and still brings tears to my eyes. She had stayed with us before when her baby was weaning, so the gang all knew her. But this time she was pretty stressed out. Good old Mozie sidled right up to her and blew a horse kiss on her nose. He let her eat beside him in his "room" in the barn. She would startle at the slightest sound and run out of the barn if a deer walked through the woods acres away. Good old Mozie just ignored her and made that cooing sound horses do. She is a different horse today and much of that is because that big old, broken-hearted horse just kept still and calm through all her antics. After Mozie was put down Heartbreak stood guard over his body. After she said good-bye she went in and touched nosed with Delilah and Pete. I think she told them it was okay and that he was gone. That image will forever be in my mind's eye. They grieve and they let go. Pretty chill way to handle life, don't you think? Good bye Mozie. Your big old, broken, golden heart will never be forgotten. ## **RULES AND REGULATIONS:**

1. Except where noted, USEF/USDF and MHSA rules will apply.
2. The 2015 USDF/USEF tests will be used for Classes 1-10 and for CT Classes 1 and 2. We are offering a limited number of the official USEF 2017 Western Dressage tests. Copies of these tests, as well as specifications for attire, etc. may be found on the USEF website. Please bear with us as this concept is still new and will undoubtedly have some bugs to work out! The 2018 USEA tests will be used for classes 3CT and 4CT.
3. All tests to be ridden in a plain snaffle.
4. First place prize and ribbons through sixth place for all classes. High score rosettes given to the highest score achieved at Introductory, Training, First and Western dressage, and to the best overall (lowest penalty score) of all the Combined Tests offered.
5. A negative Coggins test, dated within one year, must be submitted with entry or must accompany each horse arriving on the grounds **EVEN IF YOUR HORSE IS STABLED ON THE PREMISES.**
6. **RIDE TIMES:** Will be emailed to all entrants who provide email address, or call Kim after 8 p.m. on Wednesday, September 12 at 573-442-3039.
7. **NO DOGS PLEASE!**
8. Casual attire is appropriate, but breeches, boots and hard hats are mandatory.
9. **NO STABLING IS AVAILABLE AT SUNNY OAK FARMS.**
10. No entries will be scheduled until check is in show manager's hands. Late entries will be accepted after closing date until show is full for an additional \$10 late fee per entry. **SHOW IS OUTDOORS AND PARKING IS IN A FIELD. SUSTAINED HEAVY RAINS PRIOR TO OR ON THE DAY OF THE SHOW WILL RESULT IN CANCELLATION. IF SHOW IS CANCELED, YOUR CHECK WILL BE RETURNED. IF SHOW IS CANCELED, SHOW MANAGER WILL NOTIFY ALL ENTRANTS BY CELL PHONE BEFORE 7 A.M. ON SEPTEMBER 15.**


